The Hon'ble Chief Minister launched the YSR Bima on 21st October 2020 and Jagananna Thodu on 25th November 2020. The Principal Finance Secretary to Government in the review meeting expressed his dissatisfaction about the progress of the said schemes by the District Administration and issued the following instructions.

- The Joint Collectors (VWS&D) are requested to depute 2 staff (Welfare Assistants + any other) to each Bank Branch in their Jurisdiction.
- The Staff deputed to the Bank Branches shall report to the Bank Branch Manager and assist him/her in Jagananna Thodu loan documentation and YSR Bima enrolment.
- Joint Collectors (VWS&D) are directed to schedule the entire target up to 10th December 2020 and ensure to complete the target of Jagananna Thodu loan disbursement and YSR Bima enrolment on or before 10th December.
- Sufficient number of persons shall be deputed to each Bank Branch for completion of the target.
- Joint Collectors (VWS&D) are requested to review with Bank Branch Managers and sort out the issues if any.
- The deputed staff shall be sit in the Bank Branch and extend all the cooperation to the Bank Branch Managers.

The Hon'ble Chief Minister will review the progress on 11th December 2020 and all the Joint Collectors (VWS&D) are requested to put their fill efforts and see to achieve the target of Jagananna Thodu loan disbursement and YSR Bima enrolment on or before 10th December 2020 without fail.

If considerable progress is not shown it will be viewed seriously and necessary action will be taken against the responsible persons
