Minutes of the Tele Conference held on 26.05.2021 on, Jagananna Thodu with Joint Collectors (VWS&D), Municipal Commissioners, PDs DRDA, PDs MEPMA, LDMs and DLDOs

The Special Chief Secretary, GVWV&VSWS Department has conducted Teleconference with all the Joint Collectors (VWS&D), Municipal Commissioners, PDs DRDA, PDs MEPMA, LDMs and DLDOs on progress of Jagananna Thodu on 26.05.2021. He explained the status and expressed his dissatisfaction on the slow progress. Further he said that the Hon'ble Chief Minister also expressed strong displeasure about the low progress and not achievement of target of Jagananna Thodu and PM SVANidhi which helps small & Petty Businesspersons, Fruit/ Vegetable Vendors and other Street Vendors during the COVID period. After detailed discussions and deliberations he has issued following instructions:

- All the Municipal Commissioner and PDs MEPMA are requested to sponsor atleast 1.30 lakh applications to DCCB and many applications may cover under PM SVANidhi which is meant for Urban Areas and its progress covers under Jagananna Thodu scheme.
- PDs MEPMA and Municipal Commissioners shall depute Volunteers, Ward Secretariat and MEPMA staff to the DCCB Branches for assisting in opening of accounts and completion of loan documentation. Further he requested to submit all physical applications to the Branches and obtain acknowledgment from the Branches.
- The Municipal Commissioners of Big Municipal Corporations like GVMC, VMC, Rajahmundry, Kakinada, Guntur, Nellore and Tirupati are requested to sponsor atleast 10,000 applications per Corporation to the DCCB Branches duly deputing the staff for Assisting Branches. Other Corporations and Municipalities shall sponsor atleast 5000 applications per ULB to the DCCB Branches. They may cover not only Street Vendors but also Shop Owners who have 10' x 10' built up area under this scheme.
- In Rural Areas there are 28000 Village Organizations, all PDs DRDA are requested to sponsor at least not less than 10 applications per Village Organization and get sanction of 2.80 lakhs under Streenidhi

- and interest will be borne by the Government.
- For processing of Streenidhi applications may follow the existing procedure /process only and not to link with Volunteers APP or GSWs Portal.
 - All the Joint Collectors (VWS&D) are requested to review to Municipal Commissioners, PDs DRDA, PDs MEPMA and ensure to achieve the target of 4 lakhs by 31st May 2021 duly extending necessary Assistance / Cooperation to them.
 - From today onwards daily Teleconferences will be conducted until the achievement of progress and anybody wants to get clarification may post in the WhatsApp group which is created separately for Jagananna Thodu.
 - All the District Officers are requested to work as a team and improve progress drastically, if progress is not shown appropriate action will be initiated.

Director, GVWV&VSWS Department:

The Director, GVWV&VSWS Department has explained the progress and status of Jagananna Thodu / PM SVANidhi. Further he explained the instructions of the Hon'ble Chief Minister during the Spandana Video Conference conducted on 26.05.2021 and requested all the Districts shall achieve the target.

MD, MEPMA:

MD, MEPMA has explained the PM SVANidhi progress and sponsoring of applications to the DCCB Branches and promised to achieve the target.

All the Joint Collectors (VWS&D) are requested to focus on the Jagananna Thodu duly coordinating with Streenidhi and APCOB. If considerable progress is not shown within 2 days, the next review may be conducted by the Secretary to Hon'ble Chief Minister / the Chief Secretary. Hence requested substantial progress from all the Districts.
