1. It is to inform that, subsequent to communicating the data of un-surveyed Ration Cards data, after duly obtaining it from Civil Supplies department to the Village and Ward Secretariats, the progress achieved in completing the survey to identify the YSR Bhima Survey is to be improved and accordingly, it is proposed that, following instructions are issued,
  - I. The Welfare Assistant in Rural and Urban Areas have to personally go and sit with FP Shop dealer from which the ration was last drawn by the Ration Card holder and make enquiry about the probable location in which he is residing,
  - II. Accordingly, basing on the data received through enquiry with FP Shop Dealer, the Ration Card is to be mapped to the Volunteer concerned and the survey should be completed on priority,
  - III. If Ration Card holder is not traced out in-spite of making enquiry, the Welfare Assistant shall record his / her remarks stating that

Ration Card holder is not traceable in the FP shop area where Ration Card has been last recorded as ration drawn.

2. Accordingly, all the Joint Collectors (VSWS D) are requested to implement above the instructions scrupulously and get the survey completed on priority for identifying the beneficiaries for YSR Bhima programme.
