Government is implementing several Welfare Schemes for the welfare of the citizens and providing benefits to all eligible persons irrespective of Caste, Gender Creed, Religion, Region and Political affiliation in a transparent and corruption free manner. Out of the many Welfare Programs Pedalandariki Illu is one of the Flag Ship programs of the Government covering 30.75 lakh beneficiaries and the program was launched by the Hon'ble Chief Minister on 25th December 2020.

2. The Housing Department has fixed the Pedalandariki Illu program schedule from **25th December 2020 to 7th January 2021** and printed house sanction proceedings for all the beneficiaries sanctioned houses under Phase-I. Further option forms for construction of houses are also printed and they have to distribute to all the beneficiaries through Village/Ward Volunteers as per the scheduled fixed by the Housing Department in consultation with Hon'ble Public Representatives.

3. The Project Director, Housing will hand over the house site proceedings and option forms to the Village /Ward Secretariats by **28th December 2020**. The Engineering Assistant / Ward Amenities Secretary shall coordinate with Volunteers and Housing Department Officials. The Housing Department will be deputed their Work Inspectors/AEs/DEEs/EEs to Village/Ward Secretariats for coordinating the distribution of House Sanction Proceedings and collection of consent forms for construction of houses from the beneficiaries.


4. The GVWV&VSWs Department has developed One Volunteers APP updated 5.9 version to conduct the feedback survey of all beneficiaries whether they have received Sanction Proceedings of house, House site Patta and whether the beneficiaries have given consent for construction of houses in one of the three options given by the Housing Department. The GVWV&VSWs Department will be released the updated 5.9 version of Volunteers APP by today night.

5. The Village/Ward Volunteers shall distribute house sanction proceedings and collection of options for construction of houses as per the program schedule. Soon after distribution of house sanction proceedings and collection of options forms for construction of houses they shall conduct the feedback survey

6. The Joint Collectors are requested to issue necessary instructions to all the MPDOs and Municipal Commissioners with a direction to distribute 100% House Sanction Proceedings and collection of consent forms for construction of houses from the concerned beneficiaries through Volunteers as per the **schedule fixed by the Housing Department i.e., 25th December 2020 to 7th January 2021**. Wherever the distribution of sanction proceedings and collection of option forms is completed conduct feedback survey through Village/Ward Volunteers whether the beneficiaries have received Sanction Proceedings of house, House site Patta and options given by beneficiaries for construction of their houses.

7. The Joint Collectors are requested to ensure to implement the Pedalandariki Illu program as per the schedule from **25th December 2020 to 7th January 2021** and complete the distribution & conduct the feedback survey duly coordinating MPDOs, Municipal Commissioners and Project Directors (Housing).
