Government issued certain instructions for positioning of Village Volunteers and Ward Volunteers in the reference cited 1st & 2nd for effective delivering of Government services at the door step of all eligible households without any discrimination. Further Government issued certain instructions to fill the vacancies of Village / Ward Volunteers in the reference 3rd & 4th cited. In the reference 8th cited Government decided to restructure the organization structure of District Administration and created the third post of Joint Collector at District level exclusively to look after Village / Ward Secretariat System.

2.In the reference 9th cited, instructions issued authorizing Joint Collectors (VWS&D) to notify the Village / Ward Volunteers vacancies and requested to ensure no village /ward volunteer post is vacant. If any volunteer is not attending duties for three consecutive working days without valid reasons should be treated as vacant and may notify the vacancy on 7th day.

3.Even though clear instructions issued for the filling up of Volunteers Vacancies regularly , it is observed during the review meeting conducted by the Hon'ble Prl Secretary to Govt, GVWV & VSWS Department that there are 7120 vacancies (Rural: 5154 & Urban 1966) in apgv.apcfss.in website.

4. Due to non filling of arising vacancies regularly lot of gaps observed in implementation of Welfare Programmes . The Prl Secretary to Govt, GVWV & VSWS Department has instructed to fill the arising vacancies periodically i.e., every month on 1st and 16th regularly. The concerned MPDOs and Municipal

Commissioners shall bring the vacancies positions of Volunteers regularly to the notice of the Joint Collectors (VWS & D) .The Joint Collectors(VWS & D) are authorised to notify the vacancies as per the rules in force for the immediate filling of vacancies.

5. If any MPDOs & Municipal Commissioners fails to submit the vacancies information to the Joint Collectors (VWS & D) disciplinary action will be initiated against the defaulters.
